## 1. Aims and objectives

Our special educational needs and disabilities (SEND) policy aims to:

- > Make sure our school fully implements national legislation and guidance regarding pupils with SEND
- > Set out how our school will:
  - Support and make provision for pupils with special educational needs and disabilities
  - Provide pupils with SEND access to all aspects of school life
  - Help pupils with SEND fulfil their aspirations and achieve their best
  - Help pupils with SEND become confident individuals living fulfilling lives
  - Help pupils with SEND make a successful transition into adulthood
  - Communicate with pupils with SEND and their parents or carers and involve them in discussions and decisions about support and provision for the pupil
- > Explain the roles and responsibilities of everyone involved in providing for pupils with SEND





- > Communicate with, and involve, pupils with SEND and their parents or carers in discussions and decisions about support and provision for the pupil
- > Make sure the SEND policy is understood and implemented consistently by all staff

#### 2. Vision and values

At our school we will provide all pupils with access to a broad and balanced curriculum appropriate to their developmental stage.

We are committed to making sure all our pupils have the chance to thrive and supporting them to meet their full potential.

We are focused on creating an inclusive environment, where provision is tailored to the needs and abilities of pupils, no matter how varied.

# 3. Legislation and guidance

This is based on the statutory guidance <u>Special Educational Needs and Disability (SEND) Code of Practice, Keeping Children Safe in Education</u> and <u>working together to improve school attendance</u>. This policy is also based on the following legislation:

- > Part 3 of the Children and Families Act 2014, which sets out schools' responsibilities for pupils with SEND
- ➤ The Special Educational Needs and Disability Regulations 2014, which set out local authorities' and schools' responsibilities for education, health and care (EHC) plans, SEN co-ordinators (SENCOs) and the special educational needs (SEN) information report
- ➤ The Equality Act 2010 (section 20), which sets out the school's duties to make reasonable adjustments for pupils with disabilities

#### 4. Inclusion and equal opportunities

At our school we strive to create an inclusive teaching environment that offers all pupils, no matter their needs and abilities, a broad, balanced and challenging curriculum. We are committed to offering all pupils the chance to thrive and fulfil their aspirations.

We will achieve this by making reasonable adjustments to teaching, the curriculum and the school environment to make sure that pupils with SEND are included in all aspects of school life.

#### 5. Definitions

### 5.1 Special educational needs

A pupil has SEN if they have a learning difficulty or disability that requires special educational provision to be made for them.

They have a **learning difficulty or disability** if they have:

- > A significantly greater difficulty in learning than most others of the same age, or
- ➤ A disability which prevents or hinders them from making use of facilities of a kind generally provided for others of the same age in mainstream schools

**Special educational provision** is educational or training provision that is additional to, or different from, that made generally for other children or young people of the same age by mainstream schools.

# 5.2 Disability

Pupils are considered to have a **disability** if they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to do normal daily activities.

The school will make reasonable adjustments for pupils with disabilities, so that they are not at a substantial disadvantage compared with their peers.

## 5.3 The 4 areas of need

The needs of pupils with SEND are grouped into 4 broad areas. Pupils can have needs that cut across more than 1 area, and their needs may change over time.

AREA OF NEED	
Communication and interaction	Pupils with needs in this area have difficulty communicating with others. They may have difficulty understanding what is being said to them, have trouble expressing themselves, or not understand or use the social rules of communication.  Pupils who are on the autism spectrum often have needs that fall in this category.
Cognition and learning	<ul> <li>Pupils with learning difficulties usually learn at a slower pace than their peers.</li> <li>A wide range of needs are grouped in this area, including:</li> <li>Specific learning difficulties, which impact 1 or more specific aspects of learning, such as: dyslexia, dyscalculia and dyspraxia</li> <li>Moderate learning difficulties</li> <li>Severe learning difficulties</li> <li>Profound and multiple learning difficulties, which is where pupils are likely to have severe and complex learning difficulties as well as a physical disability or sensory impairment</li> </ul>
Social, emotional and mental health	<ul> <li>These needs may reflect a wide range of underlying difficulties or disorders. Pupils may have:</li> <li>Mental health difficulties such as anxiety, depression or an eating disorder</li> <li>Attention deficit disorder, attention deficit hyperactive disorder or attachment disorder</li> <li>Suffered adverse childhood experiences</li> <li>These needs can manifest in many ways, for example as challenging, disruptive or disturbing behaviour, or by the pupil becoming withdrawn or isolated.</li> </ul>





AREA OF NEED		
Sensory and/or physical	Pupils with these needs have a disability that hinders them from accessing the educational facilities generally provided.	
	Pupils may have:	
	<ul> <li>A sensory impairment such as vision impairment, hearing impairment or multi-sensory impairment</li> </ul>

	These pupils may need ongoing additional support and equipment to access all the opportunities available to their peers.	

#### 6. Roles and responsibilities

#### 6.1 The SENCO

The SENCO is Nikki Maltby – nikki.maltby@theshires.org.uk – 01780 411944.

#### The SENCO will:

- > Liaise with parents/carers about their child/young person's SEND and identify/review any developing needs and identify/coordinate any provision that might be required
- > Work with the Headteacher, Clinical Lead & Governors to determine the strategic development of the SEND policy and provision in the school
- ➤ Have day-to-day responsibility for the operation of this SEND policy and the co-ordination of specific provision identified within EHC plans across the school
- > Provide professional guidance to colleagues and liaise and work with staff, parents, and other agencies to make sure that pupils with SEN receive appropriate support and high-quality teaching
- > Advise on the graduated approach to providing SEN support and differentiated teaching methods appropriate for individual pupils
- > Advise on the deployment of the school's delegated budget and other resources to meet pupils' needs effectively
- > Be a point of contact for external agencies, especially the local authority (LA) and its support services, and work with external agencies to make sure that appropriate provision is provided
- ➤ Liaise with potential next providers of education to make sure that the pupil and their parents/carers are informed about options and that a smooth transition is planned
- > When a pupil moves to a different school or institution: Make sure that all relevant information about a pupil's SEN and the provision for them are sent to the appropriate authority, school or institution in a timely manner
- > Work with the Headteacher and school governors to make sure the school meets its responsibilities under the Equality Act 2010 with regard to reasonable adjustments and access arrangements
- > Make sure the school keeps its records of all pupils with SEND up to date and accurate





- > With the Headteacher, monitor to identify any staff who have specific training needs regarding SEN, and incorporate this into the school's plan for continuous professional development
- > With the Headteacher, regularly review and evaluate the breadth and impact of the SEND support the school offers or can access
- > Prepare and review information for inclusion in the school's SEN information report and any updates to this policy
- > With the Headteacher and teaching staff, identify any patterns in the school's identification of SEN, both within the school and in comparison with national data, and use these to reflect on and reinforce the quality of teaching

# 6.2 The governing board

The governing board is responsible for making sure the following duties are carried out, though the duties can be delegated to a committee or an individual:

- > Do all it can to make sure that every pupil with SEND gets the support they need
- > Make sure that pupils with SEND engage in the activities of the school
- > Inform parents/carers how the school is supporting to provide special educational provision for their child
- Make sure that the school has arrangements in place to support any pupils with medical conditions
- > Provide access to a broad and balanced curriculum
- ➤ Have a clear approach to identifying and responding to SEND
- > Provide an annual report for parents/carers on their child's progress
- > Record accurately and keep up to date the provision made for pupils with SEND
- > Publish information on the school website about how the school is implementing its SEND policy, in an SEN information report
- > Make sure that there is a qualified teacher designated as SENCO for the school and that the key responsibilities of the role are set out, and monitor the effectiveness of how these are carried out
- > Determine their approach to using their resources to support the progress of pupils with SEND
- > Make sure that all pupils from year 8 until year 13 are provided with independent careers advice

#### 6.3 The SEND link governor

The SEND link governor is Charlotte Niekerk.

The SEND governor will:

- > Help to raise awareness of SEND issues at governing board meetings
- > Monitor the quality and effectiveness of SEND provision within the school and update the governing board on this
- > Work with the Headteacher and SENCO to determine the strategic development of the SEND policy and provision in the school

# **6.4 The Headteacher**





The Headteacher is Jamie Hill.

The Headteacher will:

- > Work with the SENCO and SEND link governor to determine the strategic development of the SEND policy and provision within the school
- > Work with the SENCO and school governors to make sure the school meets its responsibilities under the Equality Act 2010 with regard to reasonable adjustments and access arrangements
- ➤ Have overall responsibility for, and awareness of, the provision for pupils with SEND, and their progress
- > Make sure that the SENCO has enough time to carry out their duties
- > Have an overview of the needs of the current cohort of pupils on the SEND register
- > Advise commissioning LA when a pupil's EHC plan needs an early review because of change in identified needs/provision requirements
- > With the SENCO, monitor to identify any staff who have specific training needs regarding SEN, and incorporate this into the school's plan for continuous professional development
- > With the SENCO, regularly review and evaluate the breadth and impact of the SEND support the school offers or can access
- > With the SENCO and teaching staff, identify any patterns in the school's identification of SEN, both within the school and in comparison with national data, and use these to reflect on and reinforce the quality of teaching

#### 6.5 Class teachers

Each class teacher is responsible for:

- > Planning and providing high-quality teaching that is differentiated to meet pupil needs through a graduated approach
- > The progress and development of every pupil in their class
- > Working closely with any teaching assistants or specialist staff to plan and assess the impact of teaching, classroom support and interventions
- > Working with the SENCO to review each pupil's progress and development, and decide on any changes to provision
- > Ensuring they follow this SEND policy and the SEN information report
- > Communicating with parents/carers regularly to:
  - Set clear outcomes and review progress towards them
  - Discuss the activities and support that will help achieve the set outcomes
  - Identify the responsibilities of the parent, the pupil and the school
  - Listen to the parents'/carers' concerns and agree their aspirations for the pupil

#### 6.6 Parents or carers

Parents or carers should inform the school if they have any concerns about their child's progress or development.





Parents or carers of a pupil at the school will always be given the opportunity to provide information and express their views about the pupil's SEND and the support provided. They will be invited to participate in discussions and decisions about this support. They will be:

- > Invited to termly meetings to review the provision that is in place for their child
- > Asked to provide information about the impact of SEN support outside school and any changes in the pupil's needs
- > Given the opportunity to share their concerns and, with school staff, agree their aspirations for the pupil
- > Given an termly report on the pupil's progress

The school will take into account the views of the parents or carers in any decisions made about the pupil.

# 6.7 The pupil

Pupils will always be given the opportunity to provide information and express their views about their SEND and the support provided. They will be invited to participate in discussions and decisions about this support. This might involve the pupil:

- > Explaining what their strengths and difficulties are
- > Contributing to setting targets or outcomes
- > Attending review meetings
- > Giving feedback on the effectiveness of interventions

The pupil's views will be taken into account in making decisions that affect them, whenever possible.

# 7. SEN information report

The school publishes a SEN information report on its website, which sets out how this policy is implemented in the school.

The information report will be updated annually and as soon as possible after any changes to the information it contains.

#### 8. Our approach to SEND support

## 8.1 The graduated approach to SEN support

Once a pupil enters our school we will take action to remove any barriers to learning, and put effective special educational provision in place. This support will be delivered through successive rounds of a 4-part cycle known as the graduated approach.

#### 1. Assess

The pupil's class teacher and the SENCO will carry out a clear analysis of the pupil's needs. The views of the pupil and their parents/carers will be taken into account. The school may also seek advice from external support services.

The assessment will be reviewed regularly to help make sure that the support in place is matched to the pupil's need. For many pupils, the most reliable way to identify needs is to observe the way they respond to an intervention.

#### 2. Plan





In consultation with the parents/carers and the pupil, the teacher and the SENCO will decide which adjustments, interventions and support will be put into place, the expected outcomes, and a clear date for review.

All staff who work with the pupil will be made aware of the pupil's needs, the outcomes sought, the support provided and any teaching strategies or approaches that are needed. This information will be recorded on our management information system, and will be made accessible to staff via the pupil's "All About Me" documentation.

Parents/carers will be fully aware of the planned support and interventions, and may be asked to reinforce or contribute to progress at home.

#### 3. Do

The pupil's class or subject teacher retains overall responsibility for their progress.

Where the plan involves group or 1-to-1 teaching/support, the teacher still retains responsibility for the pupil. They will work closely with any teaching assistants or specialist staff involved, to plan and assess the impact of support and interventions and how they can be linked to classroom teaching.

The SENCO will support the teacher in further assessing the pupil's particular strengths and weaknesses, in problem solving and advising on how to implement support effectively.

#### 4. Review

The effectiveness of the support and interventions and their impact on the pupil's progress will be reviewed in line with the agreed date.

We will evaluate the impact and quality of the support and interventions. This evaluation will be based on:

- The views of the parents/carers and pupils
- The level of progress the pupil has made towards their outcomes
- The views of teaching staff who work with the pupil

The teacher and the SENCO will revise the outcomes and support in light of the pupil's progress and development, and in consultation with the pupil and their parents/carers.

## 8.2 Education, health and care (EHC) plan

All pupils that attend Stretton Shires School have an EHC plan. The plan is a legal document that describes the needs of the pupil, the provision that will be put in place, and the outcomes sought.

# 8.3 Evaluating the effectiveness of SEN provision

We evaluate the effectiveness of provision for pupils with SEN by:

- > Tracking pupils' progress, including by using provision maps
- > Carrying out the review stage of the graduated approach in every cycle of SEN support
- > Using pupil questionnaires
- > Monitoring by the SENCO
- > Holding annual reviews for all pupils with EHC plans
- > Getting feedback from the pupil and their parents/carers





#### 9. Attendance and Admissions

Many pupils with SEND face complex barriers to attendance. Their right to an education is the same as any other pupil and therefore the attendance ambition for these pupils is the same as it is for any other pupil. However, they may need additional support.

Our approach to supporting pupils who are absent from school due to their SEND is set out in our attendance policy.

# 10. Safeguarding

We recognise that pupils with SEND can face additional safeguarding challenges. Children with disabilities are more likely to be abused than their peers, and additional barriers can exist when recognising abuse, exploitation and neglect in this group.

For more details of the pastoral support we offer pupils with SEND, and the support we provide to help pupils overcome any communication barriers they face, see our safeguarding/child protection policy.

# 11. Expertise and training of staff

Training will regularly be provided to teaching and support staff. The Headteacher and the SENCO will continuously monitor to identify any staff who have specific training needs and will incorporate this into the school's plan for continuous professional development.

# 12. Links with external professional agencies

The school will work with external support services to meet the SEND needs of pupils, such as:

- Speech and Language Therapists
- Occupational Therapists
- Psychotherapists
- Specialist Teachers or support services
- Educational Psychologists / Clinical Psychologists
- General Practitioners or Paediatricians
- School nurses
- Child and adolescent mental health services (CAMHS)
- Education welfare officers
- Social services

#### 13. Complaints about SEND provision

Where parents/carers have concerns about our school's SEND provision, they should first raise their concerns informally with the Headteacher. We will try to resolve the complaint informally in the first instance. If this does not resolve their concerns, parents are welcome to submit their complaint formally.

Formal complaints about SEND provision in our school should be made to the Headteacher in the first instance. They will be handled in line with the school's <u>complaints policy</u>.

# 14. Monitoring and evaluation arrangements

#### 14.1 Evaluating the effectiveness of the policy

We are constantly looking for ways to improve our SEND policy. We will do this by evaluating whether or not we are meeting our objectives set out in section 1.

We will evaluate how effective our SEND provision is with regards to:

- > All staff's awareness of pupil SEND needs at the start of the Autumn Term
- > Provision audit and review to ensure all provision is being delivered across the school
- > Pupils' progress and attainment once they have been on roll at the school for a minimum of 12 weeks
- > Whether pupils feel safe, valued and included in the school community
- > Comments and feedback from pupils and their parents/carers

# 14.2 Monitoring the policy

This policy will be reviewed by the Headteacher annually. It will also be updated when any new legislation, requirements or changes in procedure occur during the year. It will be approved by the board of governors during the first governance meeting of the new academic year.
